**THE OFFICIAL PROCEEDINGS OF THE GERING PLUMBING BOARD MEETING
December 16, 2025**

A meeting of the City of Gering Plumbing Board was held in open session on December 16, 2025 at 5:18 p.m. in the Gering City Hall Council Chambers, 1025 P Street, Gering, NE. Present were Board Members Mathew Beebe, Jeff Vance (5:23 p.m.), Josh Schlaepfer and Lucan Palomo. Absent: Mike Davies. Also present was City Engineer Annie Folck and Administrative Support Specialist Karen Heins.

1. Call to Order

Chairman Beebe called the meeting to order at 5:18 p.m. and roll call was taken.

2. Open Meetings Act

Chairman Beebe reviewed the Nebraska Revised Statutes Chapter 84, Article 14, which requires at least one copy of the Open Meetings Act be posted in the meeting room.

Notice of the meeting was given in advance thereof by publication in the Star Herald, the designated method of giving notice. Availability of the agenda was communicated in advance to the Media and Board Members. All proceedings hereafter were taken while the meeting was open to the attendance of the public.

3. Approval of the November 12, 2025 Minutes

Board Member Schlaepfer moved to approve the minutes from the November 12, 2025 regular meeting. It was seconded by Board Member Palomo. On roll call vote, the following voted "AYE": Mathew Beebe, Josh Schlaepfer and Lucan Palomo. Absent: Jeff Vance and Mike Davies.

4. Current Business

A. Review and consider approval of application for Journeyman Mechanical License – Dylan S Chamness

Discussion: The Board reviewed the applicant's work history. Chairman Beebe stated that he has previously worked with Mr. Chamness and was able to vouch for his time and experience. It was noted that Mr. Chamness is the son of Matt Kautz. The Board confirmed that the applicant had passed the required examination.

Board Member Schlaepfer moved to approve granting a Journeyman Mechanical License to Dylan S Chamness. The motion was seconded by Board Member Beebe. There was no further discussion. 5. City Building Inspector Report (Information only)

Engineer Folck updated the Board on prior discussions held at the November Plumbing Board meeting regarding reciprocity license approvals. The discussion centered on potential changes to allow provisional licenses to be issued while awaiting formal action by the Plumbing Board when an individual applies for a plumbing or mechanical license. Legal counsel has drafted proposed language to be presented to City Council in January that would permit an applicant to work under a provisional reciprocity license for up to 30 days. This would allow time for the Plumbing Board to be scheduled and convene during that interim period.

Building Inspector Vance arrived and noted he did not have any items to report.






