

INVITATION TO BID

1.1 PROJECT INFORMATION

- A. Notice to Bidder: Qualified bidders are invited to submit bids for Project as described in this Document according to the Instructions to Bidders.
- B. Project: **Oregon Trail Park Field One Renovations**
- C. Owner: **City of Gering, 1025 P Street, Gering, NE. 69341**
- D. Engineer: **Annie Folck P.E., City of Gering**
- E. Project Description: **Finish grade work for baseball infield, to include all necessary re-sodding and infield surface mix. Project will also include warning track adjustments and surface mix as indicated on plans.**
- F. Construction Contract: Bids will be received for the following work:
 - 1. General Contract (all trades.)

1.2 BID SUBMITTAL AND OPENING

- A. Owner will receive sealed bids until the bid time and date at the location indicated below. Owner will consider bids prepared in compliance with the Instruction to Bidders issued by Owner, and delivered as follows:

1.3 BID SECURITY

Bid security shall be submitted with each bid in the amount of 5 percent of the bid amount. No bids may be withdrawn for a period of 60 days after opening of bids. Owner reserves the right to reject any and all bids and to waive informalities and irregularities.

1.5 TIME OF COMPLETION AND LIQUIDATED DAMAGES

Liquidated damages will be assessed at **\$1,000.00** for each consecutive calendar day for which the work is not substantially complete and **\$1,000.00** for each consecutive calendar day for which all of the work listed on the punch list is not complete. Anticipated Notice to Proceed will be on **March 3, 2025**.

1.6 BIDDER'S QUALIFICATIONS

- A. Bidders must be properly licensed under the laws governing their respective trades and be able to obtain insurance and bonds required for the work.
- B. Bidder must provide references on past work experience with similar projects.

1.7 OTHER REQUIREMENTS

- A. A Performance and Payment Bond is required on this project.
