A regular meeting of the City Council of Gering, Nebraska was held in open session on January 24, 2022, at 6:00 p.m. at Gering City Hall, 1025 P Street, Gering, NE. 2. Approve and authorize the Mayor to sign Interlocal Agreement between the City of Gering and the City of Gering Community Redevelopment Authority

Motion by Councilmember Morrison to approve and authorize the Mayor to sign an Interlocal Agreement between the City of Gering and the City of Gering Community Redevelopment Authority. 3. Approve Resolution 1-22-3 regarding imposing a 1/2% additional sales tax to the existing City Sales and Use Tax for the purpose of funding public infrastructure projects

- a. The City currently imposes a City Sales and Use Tax in the amount of 1.5% pursuant to the Local Option Revenue Act, Sections 77-27,142, et seq. of the Nebraska Statutes (the "Existing City Sales and Use Tax");
 - b. The City is in need of additional revenue in order to provide for public infrastructure projects;
- c. §77-27, 142 of the Nebraska Statutes allows the City Council to impose an additional one-half percent (1/2%) sales tax in addition to the Existing City Sales and Use Tax for the purpose of funding public infrastructure projects, following an election at which a majority of the qualified electors of the City approve such additional sales and use tax;
- d. The additional sales and use tax may not be imposed unless the City is a party to an interlocal agreement pursuant to the Interlocal Cooperation Act, Sections 13-801 to and including 13-1827, Reissue Revised Statutes of Nebraska, as amended (the "Interlocal Act"), with a political subdivision within the municipality or the county in which the City is located, which interlocal agreement shall create a separate administrative entity related to public projects; and
- e. The City has entered into an interlocal agreement with the City of Gering Community Redevelopment Authority, a body corporate and politic (the "CRA"), for the purposes of forming the Gering Community Infrastructure Cooperative, a separate administrative entity.

Be it resolved by the Mayor and City Council of the City of Gering, Nebraska as follows:

1. At the May 10, 2022, primary election, the following proposition in the form shown below shall be submitted to the qualified electors of the City for their approval or rejection:

Shall the City Council of the City of Gering, Nebraska increases the local sales and use tax rate by an additional one-half of one percent (1/2%) from the current rate of one and one-half percent (1-1/2%) to a total rate of two percent (2%) and impose a sales and use tax at the increased rate only for public infrastructure projects including municipal roads, streets, sidewalks, curbs and gutters; wastewater; water collection facilities, including water mains and their appurtenances, water distribution facilities, including, but not limited to, mains and their appurtenances, upon the same transactions within the City on which the State of Nebraska is authorized to impose a tax, subject to the terms and conditions set out below?

Terms and Conditions: The terms and conditions of the proposition are as follows:

- a. No reductions or elimination of other taxes or fees is contemplated.
- b. Revenues from the increased sales and use tax are to be used for the following public infrastructure projects as are allowed pursuant to §77-27,142 of the Nebraska Statutes: only for public infrastructure projects including municipal roads, streets, sidewalks, curbs and gutters; wastewater; water collection facilities, including water mains and their appurtenances, water distribution facilities, including, but not limited to, mains and their appurtenances.
- c. The City and the Community Redevelopment Authority of the City of Gering have entered into an interlocal agreement which created a separate administrative entity (the Gering Community Infrastructure Cooperative) for purposes of the interlocal agreement, related to public infrastructure projects. The interlocal agreement contains provisions, including benchmarks, relating to the long-term development of unified governance of public infrastructure projects with respect to the parties.
- d. The increased sales and use tax shall terminate no more than ten years after the effective date of the increased sales and use tax or, if bonds are issued and the local option sales and use tax revenue is pledged for payment of such bonds, upon payment of such bonds and any refunding bonds, which ever date is later, except that the portion of the rate greater than one and one-half percent imposed for the purpose of the interlocal agreement referred to above (rounded to the next higher one-quarter percent) shall not terminate.
- 2. Electors desiring to vote in favor of or against the proposition shall do so in the manner specified in the ballot form as provided by the Scotts Bluff County Clerk
- 3. The primary election shall be conducted by the Scotts Bluff County Clerk at polling places established by the County Clerk in each of the City's precincts. The polls shall be open from 7 a.m. through 7 p.m. on the day of the general election.
- 4. The following notice required by law shall be published in the Gering Citizen, a legal newspaper of general election in the City not more than 30 days nor less than 10 days before the date of the election. The notice shall be in substantially the following form:

City of Gering, Nebraska Notice of Election Notice is given that at the primary election on Tuesday, May 10, 2022, at the usual polling place in each precinct of the City of Gering, Nebraska, the ballot will include for the electors of the City for their approval or rejection, the following proposition:

Shall the City Council of the City of Gering, Nebraska increase the local sales and use tax rate by an additional one-half of one percent (1/2%) from the current rate of one and one-half percent (1-1/2%) to a total rate of two percent (2%) and impose a sales and use tax at the increased rate only for public infrastructure projects including municipal roads, streets, sidewalks, curbs and gutters; wastewater; water collection facilities, including water mains and their appurtenances, water distribution facilities, including, but not limited to, mains and their appurtenances, upon the same transactions within the City on which the State of Nebraska is authorized to impose a tax, subject to the terms and conditions set out below?

- They're re-landscaping the Oregon Trail Days building with native plants and grasses they've already placed some rocks there.

OPEN COMMENT SECTION: Discussion or action by Council regarding unscheduled business will not take place. This section is for citizen comment only.

Mary Bowman, 2610 Prairie Street, stated that she is the chairperson of the committee working on replacing the platform at the cemetery. They've been working on that for about two years; it will probably take another two years to complete. She thanked Council for approving the Keno funds for this project; that really helps them get things going. They will have continuing discussions at the Legion to find out what the replacement will be. They plan to hold a Legion-wide townhall meeting – everyone in the "Legion Family" will be able to participate in discussions about the design of the pavilion. They will have a consensus of the organization as to what that will look like sometime in March.

Councilmember Morrison asked the Mayor and Council if what was approved by Council for this project veers way off-track - if the Legion and all their entities do not approve of that, can that be modified in some way? Mayor Kaufman replied that he thinks the spirit and intent of our Keno Committee making a recommendation to the Council and Council moving that forward is that we would be making in investment in an asset that would be a betterment and service to our community. As long as that design was in that line of thought and they're not asking for more funds, he didn't (personally) think there would be any issues. The group is going to have to work with City staff (already) to construct and manage a project on a City asset, so there will be guidance along the way. Mary Bowman added that they are working with the Parks and Cemetery Board; they have asked the Legion to come back to them with their final design. They're keeping an eye on the project as well.

Pat Heath, City Administrator, stated that Scotts Bluff County recently recognized the City of Gering with a plaque for "helping protect and strengthen our community during the Covid pandemic". This was primarily for our staff, and particularly Casey Dahlgrin, the main person behind this. Nathan Flowers also helped and several City staff volunteered for the Covid Clinics that were held at the City's Street Maintenance Building. Some days they vaccinated up to 600 people. Administrator Heath thanked City employees and elected officials who assisted with this endeavor.

Darrell Bentley addressed the Council and stated this would be the last time Council would see that plaque. He's been asking and thinking the City needs a trophy case in the lobby to show these kind of things. It doesn't hurt to blow our own horn a little bit. He has brought this up for years, for the public that walk in and out of the door.

ADJOURN:
