THE PROCEEDINGS OF THE REGULAR MEETING OF THE GERING CITY COUNCIL, MARCH 28, 2022

A regular meeting of the City Council of Gering, Nebraska was held in open session on March 28, 2022, at 6:00 p.m. at Gering City Hall, 1025 P Street, Gering, NE. Present were Mayor Kaufman and Councilmembers Smith, Gillen Backus, Bohl, Wiedeman, O'Neal, Morrison, Cowan. Also present were City Administrator Pat Heath, City Clerk Kathy Welfl and City Attorney Jim Ellison. Notice of the meeting was given in advance by publication in the Star-Herald, the designated method of giving notice. OPEN COMMENT: Mayor Kaufman stated that discussion or action by Council regarding unscheduled business will not take place. This section is for citizen comment only.

Charles Heeman, 1761 21st Street, Gering, addressed Council and stated he and his wife are the owners of the Western Nebraska Pioneers. His reason for being at the meeting is that he's sure Council has been briefed on the ongoing issue between the Expedition League and the Pioneers and the members of the Independence League. They have formed their own league; they did that last fall. They have a current issue here in Gering regarding their lease - he knows Council has seen the letter from the Expedition League to try and block them from playing this year. Obviously on their end, this stuff is a really major thing. It's something that came about in February, they first started talking about it in March. We need to find a resolution on this, suggestions have been made to Mr. Heath and Mr. Ellison based on what other cities in their league are doing. There are six other cities in their league that are in the same situation. Most of them have called it a third-party issue between themselves and the Expedition League; that's obviously how they (Heemans) consider it. The City of Dickinson has proactively negated the lease with the Expedition League and got a new lease with the team that plays there. Mr. Heeman stated that he has kind of felt like the City (of Gering) has been afraid of being sued by somebody who has no steak in it. The Expedition League isn't going to put a team here, they have no damages to claim if they were to sue. The Pioneers, if they are barred from playing here this year, that's going to be catastrophic for their business. As citizens of Gering, homeowners and taxpayers, employers and owners of a fairly high-profile business for the region, they'd really like to get a resolution on this, ideally maybe by the next Council meeting. They've got to know on their end of things if they're going to play this year. There are a lot of stakeholders, they have a lot of players coming to town, they have season-ticket holders and families who trust them to play. If this turns into a case where someone is so afraid of a lawsuit that they're going to bar them from playing, they'll never be able to regain that trust. The request to the Council and the City Government is that we find that resolution, hopefully within a couple weeks and get this thing past us and let the Pioneers deal with the Expedition League. They have sued them (the Pioneers) and they (the Pioneers) have counter-sued. Yes, it's no fun, it's not something that's going to be resolved any time soon, but they need to play this year to keep this business around. On their end, they just need to know if that's going to happen or not. That's their request to the Council and the City.

Administrator Heath introduced the new Library Director, Christie Clarke. She will be replacing Diane Downer. Christie started her career as a Kindergarten/First Grade teacher in Greenville, SC and then joined the Gering Public Library almost 12 years ago. She has worked for the City of Gering as a Library Assistant, the Public Services Librarian, and most currently, Youth Services Librarian. Christie has a B.A. in Elementary Education from the University of North Carolina - Chapel Hill, and a Master of Library Science degree from Emporia State University. She also holds a Nebraska Public Librarian certification.

Mark Schultz, 1506 Ave. K, Scottsbluff, addressed Council and stated he came to say thanks to the Council and everyone who was involved; he had no idea the Heemans were going to be at the meeting tonight. He must be one of those stakeholders because his employees love going to that baseball

diamond, and his friends. He has never been to a game. He spends a ridiculous amount of money advertising and he has never been to a game, but them not playing baseball this summer? He has no idea what the legal stuff is, but he's reminding everybody that this community, this whole area, gets excited about that goofy baseball team — whether they're winning or losing. He's just the guy who's reminding everyone of that. That's pretty important. He's sorry that there's an issue over something, he has no idea what it is. Mayor Kaufman stated his comments are appreciated.
