THE OFFICIAL PROCEEDINGS OF THE REGULAR MEETING OF THE GERING CITY COUNCIL, NOVEMBER 28, 2022

A regular meeting of the City Council of Gering, Nebraska was held in open session on November 28, 2022, at 6:00 p.m. at Gering City Hall, 1025 P Street, Gering, NE. Present were Mayor Kaufman and Councilmembers Backus, Bohl, Wiedeman, O'Neal, Morrison, Cowan. Also present were City Administrator Pat Heath, City Clerk Kathy Welfl and City Attorney Jim Ellison. Absent were Councilmembers Smith and Gillen. Notice of the meeting was given in advance by publication in the Star-Herald, the designated method of giving notice. All proceedings hereafter were taken while the meeting was open to the attendance of the public except as otherwise indicated.

CALL TO ORDER

Mayor Kaufman called the meeting to order at 6:00 p.m. and stated that a quorum of the Council was present and City business could be conducted.

Motion by Councilmember Wiedeman to excuse the absence of Councilmember Smith from the November 14, 2022 regular City Council meeting. Second by Councilmember O'Neal. There was no discussion. Motion by Councilmember Morrison to approve the Consent Agenda. Second by Councilmember Wiedeman. There was no discussion. Mayor Kaufman called the vote. "AYES": Backus, Bohl, Wiedeman, O'Neal, Morrison, Cowan. "NAYS": None. Abstaining: None. Absent: Smith, Gillen. Motion carried.

PUBLIC HEARINGS: None.

BIDS/PROPOSALS:

1. Approve purchase of Case 590SN Backhoe - Wastewater Department

Mike Davies, Public Works Director, stated that the Wastewater Department is replacing a back hoe that was budgeted in FY23 Budget. They're replacing a 2012 John Deere 310. Staff's recommendation is to replace it with a 2023 Case 590 SN. It's a little bigger machine; the bigger bucket and bigger machine is more conducive for the work they're doing.

Motion by Councilmember Wiedeman to approve the purchase of a Case 590SN Backhoe for the Wastewater Department through Sourcewell with Titan Machinery in the amount of \$100,796.00 after trade-in. Second by Councilmember Bohl. There was no discussion. Mayor Kaufman called the vote. "AYES": Backus, Bohl, Wiedeman, O'Neal, Morrison, Cowan. "NAYS": None. Abstaining: None. Absent: Smith, Gillen. Motion carried.

2. Approve purchase of 2023 Chevrolet 2500HD Silverado - Wastewater Department

Mr. Davies stated that this bid is part of the replacement schedule for a three-quarter ton pickup for the Wastewater Plant. The 2011 has 140,000 miles on it and has been a great pickup. He budgeted a three-quarter ton Chevy 2500 to replace the 2011. Staff will be putting a 2008 Ford F250 on public auction and keeping the 2011 as a backup pickup. Staff's recommendation is to purchase the 2023 Chevy pickup from Dan Hattan Chevrolet in Witchita, Kansas.

Councilmember Bohl asked if there was any reason for going with a Chevy over the state bid of a Ford. Mr. Davies replied that he got a bid from Sourcewell on Ford for the exact same pickup. The Chevy is \$1000 cheaper and they've had good luck with the Chevy that they've had. This pickup will be going over rough roads quite a bit; the Chevy rides a little smoother. Councilmember Bohl asked if any of our local dealers bid on this; he's struggling with spending money in Kansas. Mr. Davies replied that he talked to Team Chevrolet; they didn't want to bid it because they didn't have any idea if they could get one. Chevrolet and GM weren't on Sourcewell this year because they didn't know if the pickups were going to be available. This pickup is sitting on the lot and ready to go. The dealer has sold quite a few to the State of Kansas. He has looked around the Denver area and around Nebraska; they're just not out there.

Councilmember Morrison asked if he has to go get it; Mr. Davies replied, yes. Councilmember Bohl asked if a late model, low-mileage, used pickup would work in that same application. Mr. Davies replied that the City would pay for a used one what we'd pay for a new one in the market that it is today.

Councilmember O'Neal asked what "in stock, subject to prior sale" means on the quote that Don Hattan Chevrolet provided. Mr. Davies replied that he had quite a few of these pickups sitting in the lot. He asked if they could hold this truck, there was someone wanting to buy it in Kansas. They are holding it for Mr. Davies until tomorrow. Councilmember Wiedeman asked if this was all done on State Bid. Mr. Davies replied this one wasn't, the Ford was – on Sourcewell. Don Hattan gave him the fleet price on this pickup which is comparable to Sourcewell. He checked with Reganis in Scottsbluff; they don't even make an extended cab pickup – it's a quad cab. We'd be looking at \$53,000 for that pickup. Administrator Heath stated that this falls in line with pickup bids from a few meetings ago; we had a very short timeframe to get those pickups ordered.

Motion by Councilmember Wiedeman to approve the purchase of a 2023 Chevrolet 2500HD Silverado for the Wastewater Department in the amount of \$46,533 from Don Hattan Chevrolet. Second by Councilmember Morrison. There was no discussion. Mayor Kaufman called the vote. "AYES": Backus, Wiedeman, O'Neal, Morrison, Cowan. "NAYS": Bohl. Abstaining: None. Absent: Smith, Gillen. Motion carried.

2. Approve and authorize the Mayor to sign Professional Services Agreement by and between the City of Gering and Panhandle Regional Development, Inc.

Councilmember Wiedeman asked who Panhandle Regional Development is. Clerk Welfl explained that they are under the umbrella of PADD, they are an NDO. The reason the City has to use an NDO is because in the past the City had a Certified CDBG Grant Administrator on staff, but no longer does.

Per Bryan Venable, Executive Director of PADD: This agreement is for loan management between Panhandle Regional Development, Inc. (NDO) and the City. It formalizes the process for how the CDBG funding will pass to Prime Metal Products and be paid back. The state requires this agreement be signed.

Motion by Councilmember O'Neal to approve and authorize the Mayor to sign a Professional Services Agreement by and between the City of Gering and Panhandle Regional Development, Inc. Second by Councilmember Wiedeman. There was no discussion. Mayor Kaufman called the vote. "AYES": Backus, Bohl, Wiedeman, O'Neal, Morrison, Cowan. "NAYS": None. Abstaining: None. Absent: Smith, Gillen. Motion carried.

3. Request for Public Safety Standing Committee Meeting – Agenda item: Review and consider amending Truck Route Ordinance
